Fraud Reporting

If you suspect someone has used the personal information of your employee to file an unemployment claim and your employee confirms this is the case, report it by going to our fraud reporting form and advise your employee to file a complaint with the Federal Trade Commission at identitytheft.gov. You can submit a fraud report Monday through Friday - 6:30 a.m. to 5:30 p.m. Weekends and Holidays - 9:00 a.m. to 5:30 p.m.

Refusal to Accept Work Report

States must have a method to address circumstances in which an individual refuses to return to work or to accept an offer of suitable work without good cause. You can submit a Refusal to Accept Work Report Monday through Friday - 6:30 a.m. to 5:30 p.m. Weekends and Holidays - 9:00 a.m. to 5:30 p.m.

Employer Reporting:

One form per claimant. Employer's are not able to submit one form with multiple claimant names.
